The written examination for the post of Mandi Supervisor will be of graduation level comprising of 200 multiple choice questions as under:-

ii)	(60 questions)	Punjab Agricultural Produce Markets Acts,
		1961 and Rules and Regulations framed
		there- under.

Each question will carry 2 marks. The candidates will have to secure the minimum qualifying marks in the written examination as mentioned below:-

a) General category candidates = 50% b) SC, BC-A & BCB-B category candidates = 45%

Viva-voce test will be of 50 marks.

However, as per law laid down by the Hon'ble Apex Court, candidates equal to three times of the number of vacancies will be called for interview based on their performance in the written examination. The total marks obtained in the written examination and viva-voce will determine the merit of the candidates in their respective General/reserved categories.

Admit Card for written examination of the candidates will be uploaded on the Commission's Web-site i.e. www.hssc.gov.in, the candidates can download the admit cards from the Commission's Web-site from 10th August, 2015.
