DETAILED TERMS AND CONDITIONS:

- 1. The eligible interested Contractor/Agency/Firm may submit tenders, mentioning therein their eligibility, photocopies of various registration certificates (EPF, ESI, Labour and Police), evidence of adequacy of working capital for this contract, past experience and performance certificates from other government departments etc., for all the posts mentioned above. All the documents/papers attached with tender document must be countersigned/attested by the signing authority of the Contractor/Agency/Firm. Contractor/Agency/Firm must have service tax registration number alongwith PAN number issued by the Income Tax Department. The firms are required to mention the service charges in their quotation which will be charged by them over and above the rate fixed by Haryana Government vide letter No.16/7/2015-1GS-II, dated 6th April, 2015. The firm will have to provide the facility of EPF and ESI to the workers engaged by them during the period of contract. Conditional tender will not be accepted. Validity of tender is one year.
- 2. Earnest money of Rs.50,000/- shall be submitted alongwith the tender in shape of demand draft or pay order drawn from any scheduled bank in favour of Secretary, Haryana Staff Selection Commission, Bays No.67-70, Sector-2, Panchkula.
- 3. Minimum annual turnover of firm should be Rs.50.00 lacs for last three consecutive years.
- 4. The tender must be reached at the office of the undersigned upto 14.05.2015 at 4.00 P.M.
- 5. - 7. The Bidder shall quote the Technical and Financial Bids strictly as per the format enclosed at Annexure 1 and 2.
- 8. Each Contractor/Agency/Firm shall submit only one tender. A contractor who submits more than one tender will be disqualified.
- 9. The manpower to be provided by the agency shall always remain the employee of the agency for all intents and purpose and the Service Contractor/Agency/Firm shall alone be liable for any dispute amongst their employees and the agency, which may arise in any court of law. The Haryana Staff Selection Commission shall under no circumstances be deemed or treated as the employer of the person engaged for any purpose. The services of the person so engaged shall hereafter cease on the expiry of the term without providing him any claim for the regularization of series or any other consequential benefit.
- 10. The Contractor/Agency/Firm shall not employ any person below the age of 18 years.
- 11. The contract shall automatically expire after 31.05.2016 unless extended further by the office.

- 13.
