- (c) Consistent good academic record. (Good Academic Record as per Corrigendum dated.1.9.2016) As per Director Secondary Education vide memo No. 8/6-2015-CO.(1) dated 22.08.2016
 - "(iii) that in case of direct recruitment 'Good Academic Record' means the candidate having 50% marks after taking average of all examination i.e. $10^{th}/12^{th}/G$ raduation/Post Graduation as the case may be. However, the candidate must have atleast 50% marks in the Post Graduation."
- **E.Q.** M.A. Mathematics/M. Sc. Mathematics/Applied Mathematics with Mathematics as one of the subject at Graduation level with at least 50% marks and B.Ed. from recognized university.
