## NOTICE

Reference Haryana Staff Selection Commission's Advt. No. 3/2015, 4/2015, 5/2015, 9/2015 & 4/2016 which were published in various newspapers and also Published on Haryana Staff Selection Commission's website i.e. <a href="www.hssc.gov.in">www.hssc.gov.in</a>. Vide above said Advertisements online application forms were invited for various posts of PGTS & TGTS.

It is notified for the information of the candidates who appeared in written examination against above said Advertisements that in CWP No. 2129 of 2017 (O&M) Hon'ble Punjab & Haryana High Court has directed as order:-

"Before parting with the judgment, it is clarified that this order cannot be held to benefit only those persons who had approached this Court, but it would also have to go to all those other candidates who had applied for the posts but have not approached this Court. Consequently, the respondents are directed to issue a public notice informing all such applicants who had passed the STET examination and had cleared the written test for the posts in questions and had not approached this Court, but are otherwise similarly situated as petitioners, that they are now considered to be eligible and then consider their claims also."

Additional Chief Secretary to Govt. Haryana School Education Department vide memo No. 15/6-2017-CO(I), dated 21.04.2017 has clarified that the clause (vi) mentioned in the notifications dated 15.07.2011 and 21.07.2011 shall be construed to be having prospective effect meaning thereby that the validity of such STET certificate shall be upto 20.07.2016.

Keeping in view the clarification given by School Education Department and orders passed by Hon'ble Punjab & Haryana High Court, Chandigarh, the Commission shall consider the STET certificates, if the candidates have passed STET in the respective subject and are otherwise eligible as per terms and Conditions of the respective Advertisement. However, selection process for the posts of TGT and PGT have been kept in abeyance due to pending litigation. Date for scrutiny of documents shall be fixed in due course and published on website of the Commission.

It is further informed that all the candidates who have any interim orders in their favour shall be given opportunity for scrutiny of document/interview, as the case may be. All the absentees whose name falls in the result for scrutiny of documents but could not appear for scrutiny of documents pertaining to the advertisements referred in para 1 above and where final result after interview has not been declared shall also be given a chance to appear for scrutiny of documents. It is important to note that after the scrutiny of documents if a candidate is found eligible it will not confer any right of interview and candidates only falling within twice the number of vacancies shall be called for interview. The Candidates are advised to regularly visit the website to know the date for the respective categories and no separate individual intimation shall be given.

Others terms and conditions of the Advertisement No. 3/2015, 4/2015, 5/2015, 9/2015 & 4/2016 remain the same.
